3 Call to Order

The Indiana State University Board of Trustees met in regular session at 9:30 a.m. on Friday, February 20, 2015 in the State Room, Tirey Hall.

REPORT OF THE STAFF COUNCIL CHAIRPERSON (Mr. Torrence)

(Ms. Torrence submitted the following report)

I would like to thank all of the Council representatives that participated as well as Dr. Jeff Harper from the Scott College of Business for his role in the murder mystery. The event raised \$1,180 for the campaign.

Council representative elections are being held now through mid-March and our new slate of officers will be elected at our monthly meeting in May.

REPORT OF THE PRESIDENT OF THE STUDENT GOVERNMENT ASSOCIATION (Ms. Finley)

(Ms. Finley submitted the following report)

I am happy to be here as my last meeting as SGA President. It has been an honor and a wonderful experience being able to be a part of the Board meetings and getting to know everyone here. As this is my last report I would first like to thank the Board, President Bradley, and all others present that has supported and helped SGA throughout the past year. I am extremely thankful and I speak for everyone on SGA when I say that we greatly appreciate it. I would like to recap on the past year and also touch on things I believe could use improvements.

First, the entire SGA team has worked very hard this past year to implement and create new events and ideas that would improve student life. For example, in the fall SGA created a Fall Music Festival, headed by our Director of Student Engagement, Drew Harvey. It was something different and fun for students. It went very well and there will be another Spring Music Festival on Earth Day this April. SGA has teamed up many different departments and we believe it will be a huge success. SGA has collaborated with many different areas and organizations on campus and I believe that is something that needs to continue into the future.

Just recently, I have been putting together the Board of Elections and the Election Commissioner position for the start of the new SGA presidential election. I am very happy to say that all positions were approved by Senate. We have created a very diverse group of students for the job and I have full faith they will do an excellent job. I have also been working on the Student Trustee Committee. It will consist of one student representing different organizations. There is a strict timeline for that and I expect to see multiple applications as well as a wonderful committee.

Senate held an open forum for students that the Executive Board also joined. Students were able to express their questions and concerns to SGA. Some questions were answered at the forum, but others have been taken into consideration and many Senators are developing ideas and plans that will resolve those student concerns. Senate has also been doing a wonderful job with collaborating with the Executive Board. We have seen a major change in the relationships between branches which I believe is why we have had much success in the past year. I hope to see many senators and Executive members to stay on SGA in the future.

In just a week or so SGA will be sending members to the conference, COSGA at Texas A&M. We are able to send eight students this year instead of six which is a great improvement. Currently, SLC has 32 members. The Forest has done many things this past year, specifically this past semester. We have hosted many different theme nights for both men and women's basketball games. We have done a highlighter night, pink out, white out, camo night, 80's night and this weekend we will be doing a retro night. The Forest has ordered multiple promotional items and just recently we have ordered "Fear the Forest" shirts to shoot out to the fans at the basketball games. We have also been able to give out 30 tickets to Arch Madness for students. We would like to thank those who have sponsored us throughout the past year. Many of these theme nights would not be possible without the help of others. There are many ideas brewing for the Spring athletic events such as baseball and softball. However, we do not

have anything set in stone just yet. Our Director of Pride and Traditions, Rodney Lockman, is planning to hold a Forest registration event at the end of the year to better retain members that may forget to return next year. We are very excited to see what the Forest has in store for the rest of the year as well as the years to come!

Our Director of Academic Affairs, Lauren Karcher, has been working very hard to establish an advising award this year. Students are encouraged to send in nominations of advisors that will be considered for a new award at the Sycamore Awards at the end of the spring semester. This award was created in order to recognize advisors on their wonderful work with students to let them know that they are appreciated! We are looking forward to these awards and we believe it will bring a great pride in work for advisors as well as students who are nominating their advisors.

Once again, it has been a pleasure being able to be a part of these meetings and a different side of higher education as a whole. I have very much enjoyed my time as SGA President and I will be very sad to leave the position. I have had a pleasure getting to know you all and working with you in various areas. I am sure the next president will serve you well and I look forward to seeing SGA grow and continue to be the advocating body for students. REPORT OF THE ISU FOUNDATION PRESIDENT (Mr. Carpenter)

(Mr. Carpenter made the following comments)

Congratulations to Olivia who will be graduating. She has been a dynamic leader for Student Government.

In fund raising news The Fund for Indiana State University has surpassed the Foundation Board's \$715,000 unrestricted goal. To date the Foundation has raised more than \$810,000 from 1,036 donors. These funds will be used for essential needs for ISU. We are asking the Foundation Board for this to be a priority initiative for them.

The Faculty and Staff Campaign is now underway. The goal is to increase faculty, staff, emeriti, and retiree donors by 200 new donors. We have 30 volunteer faculty and staff campaign captains to help solicit support for the University from their colleagues.

The Development officers have made approximately 1,000 personal visits so far in fiscal year 2015 securing \$6,178,877 in cash gifts and pledges through January.

The distribution of endowment and annual scholarships for the next academic year will enable the Foundation to provide more than \$1.8 million in support of our students, programs and faculty for the 2015-2016 academic year. It is good to see growth in endowment funds.

Several golf outings will be coming up soon. The football golf outing will be held on April 25 at Hulman Links Golf Course. All proceeds benefit the football program.

The Ladies Tee will be held on May 9 at the Country Club of Terre Haute. This event raises money for the women's athletics.

The President's Scholars golf outing will be held on May 29 at the Brickyard Crossing Golf Course in Indianapolis. This is the 21st year for this event. Money raised will go to the President's Scholars Program.

Alumni golf outings will begin in June in Jasper. Other outings will be held in Sullivan, Crown Point, Terre Haute and Indianapolis. All proceeds will support Alumni Association scholarships for students attending ISU from those areas. There has been growth in attendance at these events. A lot of younger people are attending.

The Sesquicentennial Celebration Gala will be held on October 15 prior to Homecoming. We will have an opportunity to have a first look at the wonderful renovation of Normal Hall. This is a fund raising event and the proceeds from the event will establish the Sesquicentennial Scholarship endowment, which will support need-based student scholarships. Single tickets are \$625 each with a portion going to a tax-deductible gift supporting the Sesquicentennial Scholarship.

In January the Alumni Association hosted several alumni gatherings in Florida. The reception in Naples is the largest event so far. There are many ISU alumni retired in that area.

We tried something new on February 11 with a viewing party to watch the ISU/Wichita State men's basketball game at the Indiana Theater. The event was hosted by the Alumni Association and Sycamore Athletic Fund. Well over 750 alumni and fans attended the event.

The men's and women's basketball tournaments are coming up soon. The men's will be in St. Louis, Missouri on March 5-8 and the women's will be held in St. Charles, Missouri on March 11-13.

REPORT OF THE FACULY SENATE CHAIRPERSON (Dr. Guell)

(Dr. Guell submitted the following report)

Since the December Board meeting, the Senate has met twice. In January we passed the MS in Genetic Counseling program as well as the Constitutional Amendments you have on your agenda today. Those amendments garnered more than 85% faculty approval during a January balloting process. Just yesterday, we recommended the change in the name of the College of Health and Human Services and the creation of the School of Nursing within that College and we recommended approval of the academic calendar you have on your agenda today.

In June you will see further evidence of our work as you get a significant revision to Section 305 of the Handbook which covers the hiring, evaluation, tenure, and promotion process for all faculty. This has been a major and necessary undertaking as the section is currently the product of too much bolting-on of policies without sufficient attention to ensuring the document be internally consistent and inherently logical. Moreover you will see a response to the requests for comment on Amorous and Familial as well as Extraordinary Personnel Situations.

We are anxious to receive the draft Sexual Violence policy, but only in the sense that it makes us anxious. I think most of us would rather be on another planet than try to define where the line is between legitimate and illegitimate consent when it comes to intoxicated young people. It is, however, required.

From our perspective the candidates for Provost appear to be first rate...so first rate that they are finalists elsewhere We look forward to the choice of a Provost. More specially, we look forward to the selection of a Provost who has the qualities of the wise giant of a man to my right. We continue to be extraordinarily grateful he agreed to serve in this interim capacity and we hope to find someone of his abilities and dispositions.

I would like to make a brief statement regarding the budget to the entire board that summarizes concerns I expressed to the budget committee earlier today. The university has been using a "97%" rule for budgeting revenue since 2012. It has been responsible for good things and bad. That rule, however, has resulted in a massive (13%) underestimation in enrollment and an equally massive \$13.5 million (or 20%) underestimation in net tuition revenue. The faculty senate officers have objected to this methodology in each of the last two years and have asked that the President and Vice President McKee present a budget that puts all previously unbudgeted but regularly occurring items in the formal budget, that creates an appropriate financial reserve and that attempts to accurately forecast enrollments and revenues rather than purposefully underestimating them to create a pool for those necessary items. This would add to transparency. I would argue that

limiting the deployment of resources to meet student needs until the very last moment when classes are nearly full, inhibits thoughtful advising of those students into properly chosen, properly staffed and properly timed classes. To misquote one of the great Republicans of the previous century, "Extremism in the pursuit of conservative budgeting, is, in fact, a vice."

REPORT OF THE UNIVERSITY PRESIDENT (Dr. Bradley)

(Dr. Bradley submitted the following report)

The Indiana General Assembly is now in full swing, and I will give an update on the biennial budget process later in my report. However, I wanted to let you know that our students recently had a tremendous opportunity to view the state legislative process at work. The day was organized by Carly Schmitt and her graduate assistant Jennifer Monarch of The American Democracy Project. Carly was unable to be with us this morning but Jennifer is here and is joined by the American Democracy Project Student Advisory Board. I would like to invite Jennifer to say a few words about the day and the American Democracy Project overall.

Jennifer said their goal is to promote more political engagement for our students at ISU. We wanted to showcase our involvement and to show what we do. The experience gave the students an opportunity to talk with legislators. Approximately 50 legislators came down to the event. Governor Pence and Glenda Ritz came out to meet with students. Thank you for allowing us to be here today.

Later that day, the students joined me as the General Assembly recognized the 150th anniversary of the introduction of House Bill 119 on February 3, 1865, by Representative Baskin Rhoads. This bill, which received final approval on December 20, 1865, established the Indiana State Normal School. The University will be kicking off its Sesquicentennial Celebration during Homecoming of this year, and it will run through January 2020, the 150th anniversary of the opening of the Indiana State Normal School. More information will be forthcoming on this celebration.

I would like to take a moment to commend Roxanne Torrence and the Staff Council for the creative ways they are making an impact. Last fall, we shared with you the Happy video they produced to kick off the academic year. Last month, they hosted a Murder Mystery Dinner to raise funds for the United Way. Next month, they have planned a Canvas on Campus Event where participants will learn how to paint as a fund raiser for the Staff Scholarship Program. The Council works very hard representing our exempt and non-exempt staff and are tremendous representatives of our University. They also have a lot of fun doing it. Thank you, Roxanne for all that you and the Council do.

The number of Indiana State University graduates is increasing to the point where Hulman Center cannot hold all of the graduates and their families and friends at one time for the May Commencement ceremony. This is a good problem to have. I would like to have Provost Jack Maynard discuss the solution that he and the Commencement Committee have developed.

Dr. Maynard said this year because of the number of graduates, having seating for family and friends, and the length of the ceremony we have made the decision to have two ceremonies in May. The first ceremony will begin at 10:00 a.m. with the Colleges of Arts and Sciences and Education. The second ceremony will begin at 2:00 a.m. with the Colleges of Business, Nursing and Technology. Graduate students will be included in both ceremonies. There will be an alumni speaker at both ceremonies and we will have two student speakers.

The doors to Hulman Center will open at 8:00 a.m. It will be a long day and the Board will have to think about what you want to do. We hope you can attend one or both ceremonies. Receptions will be planned by each College.

Dr. Bradley said there will be a dinner on Friday evening for the honorary degree recipients. We hope you can attend one or both commencement ceremonies.

I would now like to ask Diann McKee to provide an update on the Provost search followed by John Beacon for an update on the Vice President for Student Affairs search.

Diann reported that 39 candidates submitted materials for review. Eleven were interviewed in late January. Five of the candidates were invited to campus for interviews. One candidate withdrew. All the vitas are online. It is a diverse pool. Comment sheets are available at the group meetings and will be provided to the President. The search committee meets on March 2 and will make a report to the President. The first week in March we will have a decision. Delaying is not in our best interest.

John reported there were 57 in the pool. Ten participated in airport interviews. From the ten from the airport interviews four were invited to campus for interviews. The candidates will be coming to campus the first week in March. The resumes of candidates are posted online. A decision should be made sometime in March.

In a brief update on enrollment, John reported that we are attracting more Indiana residents. We should bring in approximately 274 more Indiana students than in prior years. We are in pretty good shape with enrollment.

As discussed briefly during my strategic plan update yesterday, the House Ways and Means Committee has now released its version of the 2015-2017 state budget. This version includes more new money for higher education which means that Indiana State's loss in appropriation would be slightly less than the budget proposed by the Commission and considerably less than the budget proposed by the Governor. Our operating appropriation would be reduced by \$1.6 million under the House version (\$1.5 million in 2015-16 and an additional \$156,960 in 2016-17).

The House budget also includes \$1,383,082 each year for repair and rehabilitation of our facilities. The line items for our nursing program (\$204,000) and the Indiana Principal Leadership Institute (\$600,000) remained unchanged while DegreeLink declined by 3 percent to \$446,438. The dual credit line item showed a 77.8 percent increase to \$147,950 due to the tremendous growth we have experienced in that area.

I am pleased to report that House budget bill includes funding of \$64 million for the College of Nursing, Health and Human Services Building. You will recall that this project was also included in the Commission for Higher Education's recommendation to the legislature and the Governor's budget proposal.

We are well on our way toward making history at Indiana State University as this would be the largest state-funded project in the University's history and is a testament of support for Indiana State from our state leaders who continue to express gratitude for how we are fulfilling our mission. We are very appreciative of our local legislative delegation who have worked to advance this project including, Representatives Bob Heaton, Clyde Kersey, and Alan Morrison as well as Senator Jon Ford.

We also continue to work with local and state leaders on finding a sustainable solution for the future of Hulman Center. Hulman Center has a long history as a cultural hub and public gathering place that generates positive economic impact for the City of Terre Haute and Vigo County. It is a significant economic driver, with the ability to increase quality of life and jobs/earnings potential for residents of Terre Haute and Vigo County. State and local investment for the improvement and possible expansion of Hulman Center will help further enhance Terre Haute as a place of destination. With efforts to create attractive and functional meeting spaces for large and small groups of people and to host high-quality events for persons of all ages, Terre Haute will become far more competitive in the tourism and convention market as an affordable alternative to competitor cities. Last week, we met with county and local officials and our message was well received. We are continuing our work with Representative Bob Heaton, Representative Tim Brown, and other state leaders on this issue as well. We also greatly appreciate the efforts of our community partners, Mayor Duke Bennett, and Vigo County Council President Rick Burger.

I would also like to thank Greg Goode for his tireless work on our behalf at the State House.

REPORT OF THE BOARD CHAIRPERSON (Mr. Baesler)

(Mr. Baesler made the following comments)

Yesterday the Trustees had the opportunity to have lunch with several First Year Students. I want to thank Linda Maule for putting this lunch together. The students were very impressive and the Trustees enjoyed that very much.

At the seminars yesterday afternoon Katie Butwin gave an overview of Title IX. Katie has been in the position of General Counsel for approximately six weeks. She has a firm grasp on that subject. We thank you for your presentation.

Vice President John Beacon and Crystal Baker, Director of Student Financial Aid, gave a presentation on Financial Aid Portal and Title IV Audit. Dr. Bradley gave a strategic plan progress report. He normally gives this report in December. We appreciate all the seminar presentations.

Governor Pence was at the Terre Haute Chamber of Commerce recently and Dr. Bradley and I had an opportunity to meet with him.

I met with Dr. Gerda Govine, a consultant from California, who is on campus conducting a diversity study for the campus. She is very thorough. I commend Dr. Bradley for asking for this study.

I attended the State Board of Accounts Exit interview recently. They were very complimentary of Diann McKee and her staff. The audit went very well.

The first meeting of the Finance Committee was held this morning. Thanks to Diann for her presentation. For the first meeting I thought it went very well. The members of the committee are Chair Randy Minas, Kathleen Cabello and Jeff Taylor.

ISU was again recognized by The Carnegie Foundation for Community Engagement. Thanks to all faculty and staff who submitted the application to The Carnegie Foundation.

5b Finance Committee Report (Mr. Minas)

The Finance Committee of the Indiana State University Board of Trustees met at 7:30 a.m. on February 20, 2015. In addition to myself, Finance committee members Jeff Taylor and Kathy Cabello were present. Other trustees in attendance included Bob Baesler and Ed Pease.

In addition to the action items listed on your agenda for which the Finance Committee will make recommendations, the Committee also discussed a schedule of regular review items that the Committee will consider at each of its meetings.

Information presentations were also made by Vice President Diann McKee in the development of tuition recommendations and the 2015-2017 Budget which the Board will be considering at its June meeting.

I will provide our recommendations on the action items as they are considered.

These meetings are open to the public and everyone is invited to attend.

5b1 Parking Permit Fees, 2015-16

Maintenance of University owned parking lots is funded solely through parking permit fees charged annually to faculty, staff, and students who utilize these facilities. Operational expense to develop and maintain parking lots include cost of paving, seal coating, stripping, and snow removal. Parking fees proposed for 2015-16, shown below, reflect minor increases between \$1 and \$4 per year over the 2014-15 rates with the exception of daily and department guest permit rates that remain unchanged:

*Does not include metered, pay, or specialty lots

Parking permit fees for full time faculty and staff may be paid through payroll deduction either before or after taxes at the choice of the faculty or staff member. Renewal or purchase of parking permits is offered on-line. A \$15.00 surcharge is assessed in conjunction with parking permit rates if purchased in person in the Office of Traffic and Parking Services. The surcharge does not apply to purchases

made thru payroll deduction or to students and employees purchasing permits during orientation. The surcharge applies to all other faculty, staff, and student parking permit purchases.

Recommendation: Approval of the parking permit fees listed above for 2015-16, effective August 16, 2015.

Mr. Minas reported that the Finance Committee unanimously recommends the approval of the item as presented. The board voted to approve the item as presented.

5b2 Year-End Closings

The State Board of Accounts has advised that the Treasurer of Indiana State University obtain approval from the ISU Board of Trustees to make year-end closing entries. These entries normally consist of making transfers, adjustments, and consolidations necessary to ensure the elimination of minor budgetary overdrafts, and the write-off of bad debt. The closing of the financial records is guided by GASB accounting and reporting standards and best business practices.

Recommendation: Authorization of the Treasurer or designee to make all necessary year-end closing entries and distributions.

Mr. Minas reported that the Finance Committee unanimously recommends approval of the item as presented. The board voted to approve the item as presented.

Mr. Minas reported that the Finance Committee also reviewed the draft of the Federal A-133 Audit Report.

5c New Program, Genetic Counseling M.S.

The M.S. in Genetic Counseling is a comprehensive program to train students toward certification in Genetic Counseling. Students will gain a thorough education in Human Genetics, Cytogenetics, Genomics, Genetic Disorders, Diagnostics, and the principles of counseling.

Genetic Counseling is evolving as one of the important medical programs of the post-genomic era. There is a demonstrated need for trained individuals to help patients comprehend complex information related to the genomics of their diseases and genetics-associated risks of disease development. The M.S. in Genetic Counseling is a comprehensive degree program designed to prepare students for careers in Genetic Counseling. This program will include an in-depth exploration of human genetics including: basic genetic principles, cytogenetics, diagnostics, genomics, and counseling patients regarding genetic risk and personal genomic information. This is an interdisciplinary program that has its primary base in the Department of Biology and will draw courses from Biology, Psychology, and Counseling. The program will admit 8 each year for the first 2 years and will grow to a target admission of 15 for each cohort.

This program's development was supported by the University's Unbounded Possibility Initiative.

Recommended New Program Fee:

This program will require a high level of support and special program fees will be required. These fees will be used for consumable items, special laboratory equipment, software upgrades, limited criminal background checks, service and maintenance contracts, clinical supervision, student research, animal care and processing fees, clinical supervisor mileage, and student travel.

It is proposed that a program fee of \$2,000 be attached to BIO 689. Students will enroll in this course four times during completion of the Genetic Counseling Program. Total program fees of \$8,000 will be collected from each student.

The proposal and program fees have been approved by the Dean of the College of Arts and Sciences, Dean of Graduate and Professional Studies, Faculty Senate, and have the support of the Provost and Vice President for Academic Affairs.

Recommendation: That the Genetic Counseling M.S. program and the proposed new Program Specific Fees, in the College of Graduate and Professional Studies, be approved effective Fall 2015, pending approval by the Indiana Commission for Higher Education.

On a motion by Mr. Pease, seconded by Mr. Taylor, the recommendation was approved.

5d College Name Change

Change name of College from “College of Nursing, Health, and Human Services” to “College of Health and Human Services”

A College name change is being proposed pending the approval of the School of Nursing within the College of Nursing, Health and Human Services structure. Removing the name “nursing” from the College title eliminates redundancy with multiple “nursing” titles, appropriately shortens the college name, and aligns with other peer institutions that house a School of Nursing within a College Structure. Examples are listed below.

Ball State University- School of Nursing housed in a College of Applied Sciences and Technology

Purdue University- School of Nursing housed in a College of Health and Human Services

Western Kentucky University- School of Nursing housed in a College of Health and Human Services

The proposal has been approved by the Dean of the College of Nursing, Health, and Human Services, Faculty Senate, and has the support of the Provost and Vice President for Academic Affairs.

Recommendation: That the “College of Nursing, Health, and Human Services” be changed to “College of Health and Human Services”, effective July 1, 2015.

On a motion by Mr. Pease, seconded by Mr. Campbell, the recommendation was approved.

5e Creation of School of Nursing

The Department of Baccalaureate Nursing, Baccalaureate Nursing Completion, Advanced Practice Nursing and heretofore referred to as the “Nursing Unit” at Indiana State University requests that the unit be renamed a School of Nursing. The reporting structure within the College of Nursing, Health, and Human Services (CNHHS) would not change. No new administrative structure would be necessary, as the Executive Director of Nursing would remain as the nurse administrator for the School of Nursing as required by the accrediting body.

No changes to the function and reporting lines of the nursing chairpersons would occur. No changes to the existing College Constitution would be necessary. The current structure is already functioning like a school without the associated title.

There are no significant costs in making this change. The only essential change would be a change of stationery, name tags, and signage to reflect the new name.

The proposal has been approved by the Dean of the College of Nursing, Health, and Human Services, Faculty Senate, and has the support of the Provost and Vice President for Academic Affairs.

Recommendation: That The Department of Baccalaureate Nursing, Baccalaureate Nursing Completion, Advanced Practice Nursing and heretofore referred to as the “Nursing Unit” at Indiana State University, be renamed School of Nursing, effective July 1, 2015.

On a motion by Mr. Pease, seconded by Mr. Campbell, the recommendation was approved.

5f Changes to Faculty Constitution

During the past several months, the Faculty Senate has identified several changes to the Faculty Constitution that were needed. Each of these additions were reviewed and approved in accordance with the University Handbook. Each addition or change was placed before the faculty for a vote and each surpassed the necessary 40% voter participation and each was approved by the University Faculty

1. Add a new section to the Constitution 245.9.1.4

245.9.1.4 Authorization to Make Minor Changes: When there is a need to make a change to any portion of the Handbook, including this Constitution, where that change is either merely grammatical or solely in response to a title change for a referenced position or office, the administration is authorized to execute that change upon Executive Committee of the Faculty Senate certification of the minor and inconsequential nature of that change. The Chairperson of the Faculty Senate will transmit that certification to the faculty.

Rationale: The rationale for the addition is that there are often a number of changes that must be made to the Handbook because a grammatical error has been found, or a committee or office name has changed, etc. This section allows the minor changes to be corrected by the administration and not require votes from all parties

2. Add a new section to the Constitution 245.3.3.4 and renumber 245.3.3.4 - 245.3.3.6 to be 245.3.3.5-245.3.3.7

245.3.3.4 Attendance Policy: Senators on leave who will not be attending the Senate meetings for a semester are expected to notify the Senate Chair so that temporary alternates can be appointed. Other senators who miss two meetings in a semester will be reminded by the Senate Chair of their obligation to attend. If the senator misses an additional meeting during the remainder of the academic year, the senator will lose his/her seat, an alternate will be appointed if one is available, and the college the senator had represented will be notified of the change of status.

With this new section, renumbering is required - 245.3.3.4 - 245.3.3.6 to be 245.3.3.5-245.3.3.7

Rationale: This change is to ensure attendance and appropriate faculty representation at Senate meetings.

3. Modification to Faculty Constitution Section 245.3.4

Proposed Language

245.3.4 Officers of the University Faculty Senate.

245.3.4.1 Composition. The officers of the University Faculty Senate shall be a Chairperson, a Vice Chairperson, a Secretary, and a Parliamentarian. Only elected faculty members may serve as officers.

245.3.4.2 Term. The officers shall serve for one (1) year but may be re-elected.

245.3.4.3 Timing. The Chairperson, Vice Chairperson, and the Secretary of the newly constituted University Faculty Senate shall be elected at the first organizational meeting. The Parliamentarian shall be nominated by the Executive Committee of the Faculty Senate at its first meeting. This nomination shall be presented for confirmation by the members of the Faculty Senate at the first meeting of the Senate each fall.

245.3.4.4 Presiding Officers. The University President, or in his/her absence the Provost and Vice President for Academic Affairs, shall preside at the organizational meeting of the newly constituted University Faculty Senate meeting until the officers are elected.

Current Language

245.3.4 Officers of the University Faculty Senate.

245.3.4.1 Composition. The officers of the University Faculty Senate shall be a Chairperson, a Vice Chairperson, a Secretary. Only elected faculty members may serve as officers.

245.3.4.2 Term. The officers shall serve for one (1) year but may be re-elected.

245.3.4.3 Timing. The officers of the newly constituted University Faculty Senate shall be elected at the first organizational meeting in April (Section 245.4.1).

245.3.4.4 Presiding Officers. The University President, or in his/her absence the Provost and Vice President for Academic Affairs, shall preside at this meeting until the officers are elected.

Rationale: The rationale for amendment is to bring the constitution in line with what is current practice by the Faculty Senate.

4. Changes to Faculty Constitution. Eliminate sections 245.8.5 and 245.8.6

This proposed change is to eliminate the following two sections from the Constitution.

245.8.5 Liaisons between University Faculty Senate and College/Library Governance. The governance body of each college/library shall seat a University faculty senator as a liaison.

245.8.5.1 Voting Rights. The liaison may also serve as a member of the college/ library governance body, and if such is the case, the liaison retains voting rights. If not serving as a member of the college/library body, the liaison cannot vote.

245.8.5.2 Duties of Liaisons. The liaison's duties are to report relevant actions and agendas of the University Faculty Senate to the college/library governance body, to report the relevant actions and agendas of the college/library governance body to the Senate, and generally, to facilitate communication between the Senate and college/ library governance body.

245.8.6 Council of Governance Chairs. The Council of Governance Chairs shall consist of the Chairperson of the University Faculty Senate and the Chairperson of each college/library governance body. The Chairperson of the University Faculty Senate shall serve as Chairperson of the Council of Governance Chairs.

245.8.6.1 Purpose. The Council is not a legislative body. Its purpose is to facilitate coordination of the efforts of the University Faculty Senate and the college/library governance bodies in exercising the faculty's areas of primary and advisory authority.

245.8.6.2 Meetings. The Council shall meet three (3) times during the academic year: during the first month of the fall semester, during the first month of the spring semester, and during the last month of the spring semester.

245.8.6.3 Minutes. The University Faculty Senate administrative assistant shall record minutes of the meetings to be forwarded to each governance body.

245.8.6.4 Additional Meetings. The Chairperson of the Council may call additional meetings and consider requests for additional meetings from any member of the Council.

Rationale: The rationale to eliminate these 2 sections from the constitution is that the liaison and the Council of Governance Chairs is no longer seen as necessary given the ease of electronic communication and information sharing.

Recommendation: It is the recommendation of the Provost that all proposed changes to the Faculty Constitution be approved.

On a motion by Ms. Sluyter, seconded by Ms. Bell, the recommendation was approved.

5g. Conferral of Honorary Degrees

Eston "Bud" and Alice "Annie" Perry have been long-time supporters of Indiana State University. Through The Oakley Foundation, a family-owned and operated philanthropic organization, the Perrys were instrumental in leading the beautification of Indiana State's campus by creating landscaped entryways at Seventh and Cherry (Oakley Place). The Perrys and the Oakley Foundation also helped fund the installation of a new floor for the south gymnasium of the Arena Building and have provided significant support for student scholarships. Mr. Perry is a 1961 alumnus of Indiana State, and several members of the Perry family are also alumni. Mr. Perry also is a director emeritus of the Indiana State University Foundation Board having completed numerous years of active service. The Perrys and The Oakley Foundation have also been instrumental in supporting numerous other community organizations, including Indiana State's sister institutions of higher education in Terre Haute.

Due to their long-time service and dedication to Indiana State University and to the Terre Haute community at large, Eston "Bud" and Alice "Annie" Perry are recommended for conferral of honorary degrees as indicated during the May 9, 2015 commencement ceremony

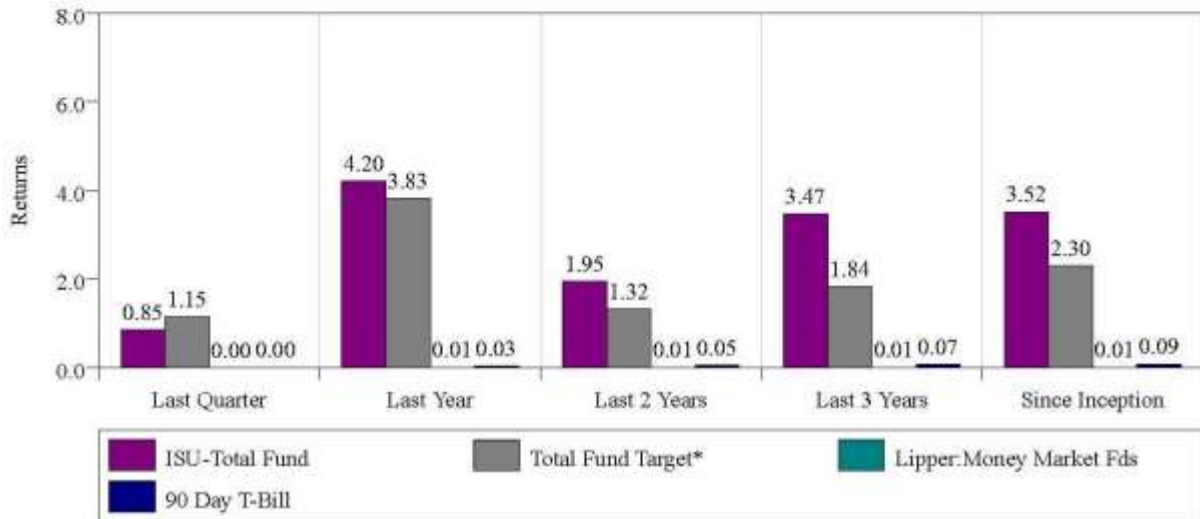

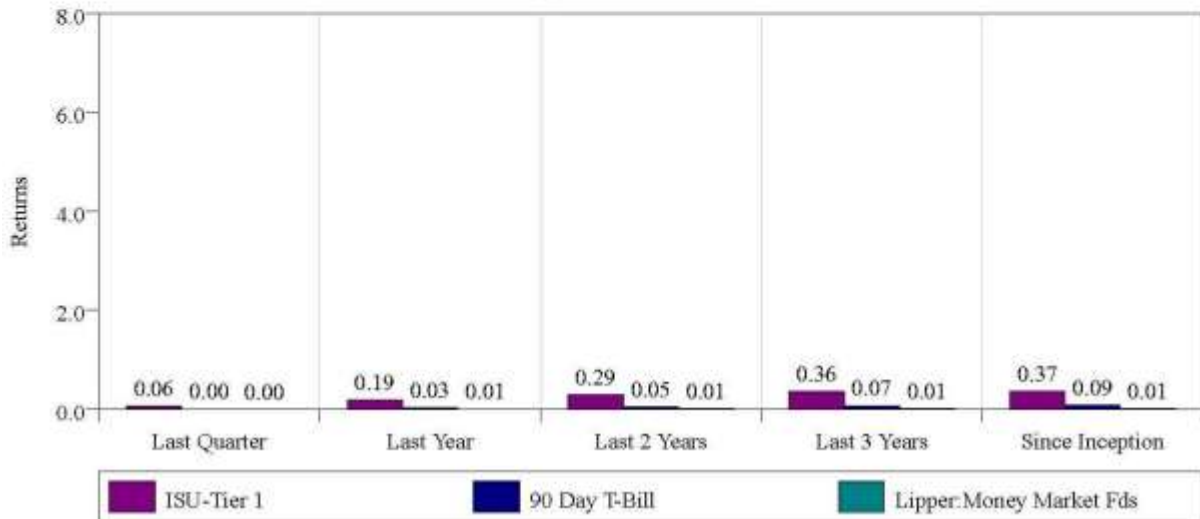

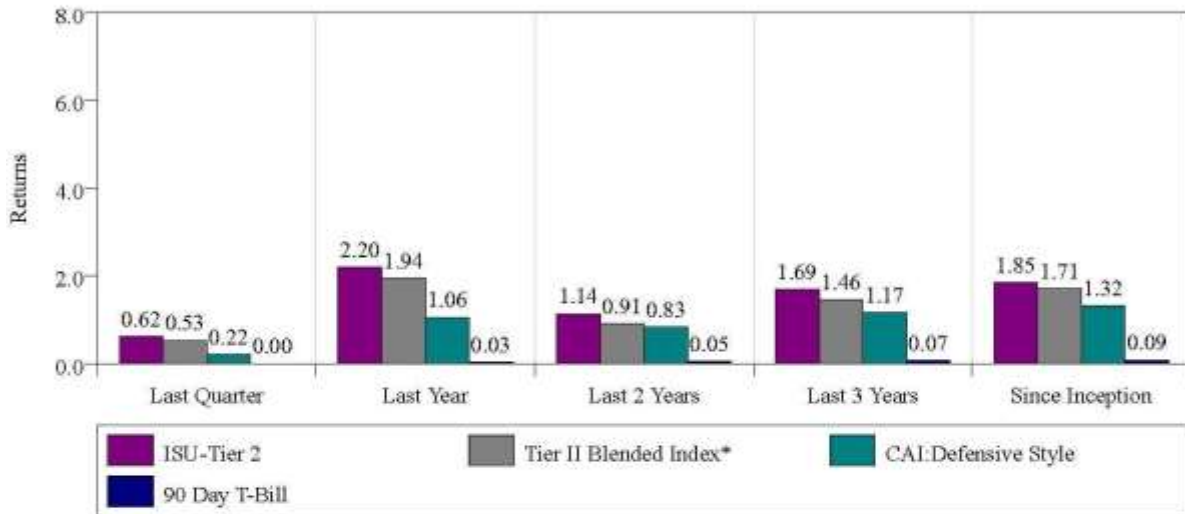

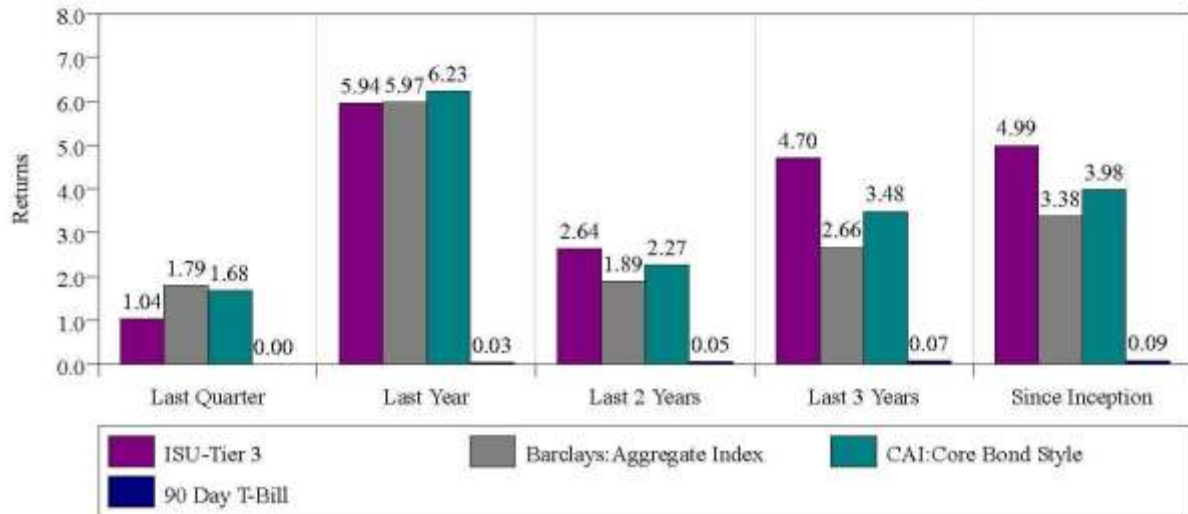

Revenues

Operational State Appropriation

The Governor's Office announced in June of 2014, after 2014-2015 University budgets had been approved by the Board of Trustees, that all public higher education institutions would continue to be subject to a 2% reserve for fiscal year 2015. Applying to operating and general fund line items, the 2% reserve is withheld monthly. To offset this loss of appropriation, a corresponding reserve was established as a part of the 2014-2015 budget to fund the 2% withholding.

Student Fees

Student Fees are above last year's total by \$2,869,605. Summer II and Fall tuition are above budget by \$97,549 and \$6,811,944, while prior year is below by \$135,368. The University's operating budget has been adjusted by \$2,558,300 to reflect \$558,300 in student wages and funding of strategic planning and unified communication projects.

Other Fees and Charges

Other Fees and Charges are above last year's level by \$45,045 due to increases in deferment and collection fees.

Sales and Services

Sales and Services shows a decrease of \$138,267 due to a timing difference of recognition of project management fees.

Miscellaneous Income

Miscellaneous Income is up \$141,164 due to increased utility reimbursement from Residential Life.

Expenses

Salaries and Wages

Salaries and wages are above last year's level by \$694,303. This is due to increases in instructional, administrative, and support staff salaries.

Fringe Benefits

Fringe benefits shows a decrease of \$302,149 largely due to half of retiree medical benefits being charged to the VEBA.

Student Wages

Student wages has a \$253,011 increase as an additional \$542,500 was added to student wage budgets to hire new students and maintain levels of employment.

Utilities

Utilities shows a decrease of \$1,056,149 to reflect lower natural gas costs while electricity showed an increase based on usage and there is an increase in sewage based on rate increases.

Training, Representation and Travel

Training, Representation, and Travel increased by \$160,361. The budget included \$275,861 of carry forward from 2013-2014.

Student Aid

Student Institutional Aid grew by \$370,040. This reflects the growth in student enrollment and the increased number of laptop scholarships provide to qualified incoming freshmen.

Supplies and Expense/Transfers

Supplies and Expense/Transfers shows an increase of \$168,617.

Repairs and Maintenance

Repairs and Maintenance is above last year's totals by \$1,953,935 which represents a realignment of budgets within OIT to more accurately reflect expenditure types.

Capital Equipment

Capital equipment has an increase of \$294,255 from last fiscal year. A total of \$2,417,662 of carry forward budget was brought forward into the new fiscal year. Many departments utilize a multiple-year planning approach for capital purchases.
