#### **REPORT OF THE FACULY SENATE CHAIRPERSON (Dr. Hawkins)**

Dr. Timothy Hawkins introduced himself as the new chair of Faculty Senate. He stated that it is a pleasure to represent the dedicated faculty of ISU who have chosen to devote their careers to educating their students, serving their community, and advancing knowledge.

Dr. Hawkins is looking forward to working with the board on behalf of faculty governance toward achieving the goals set for the university. He added that the Faculty Senate has built a very positive working relationship with the Administration of President Bradley and the Board of Trustees over the past few years, and he expects that to continue.

Dr. Hawkins asked the board to consider ways to continue the outreach that began last year with the Senate. The Executive Committee had a productive meeting with a number of trustees this past spring. He encouraged the trustees to find ways to meet with the entire Senate body over the course of this upcoming academic year.

#### **REPORT OF THE STAFF COUNCIL CHAIRPERSON (Ms. Torrence)**

Ms. Torrence reported that two ISU staff members were recognized at the Council's Annual Meeting in May. Michelle Lewis of HMSU-Operations received the Sycamore Staff Award which recognizes a staff member who contributes to the overall mission and success of Indiana State University through his/her attitude, service, and engagement. The Debbie Nelson Staff Council Spirit Award honoree was Barry Overpeck of the Controller's Office. Wil Downs, Teresa Exline, and Diann McKee served as the selection committee for this award.

Staff Council scholarships have been awarded to Pam Chamberlain, Kelly Anthony, Cory Burger, Theresa Ortega, and Rhonda Beecroft. Rachel Keyes is the recipient of the John and Jacqueline Phillips Memorial Scholarship. A recognition ceremony for all recipients will be in October.

The Public Relations Committee started the year off with a photo booth at the Welcome Back picnic. All of the pictures can be found on the Staff Council webpage. Ms. Torrence reported that the remaining standing committees are also off to a good start on their goals for the year.

### **REPORT OF THE PRESIDENT OF THE STUDENT GOVERNMENT ASSOCIATION (Mr. Velazquez)**

Andy Velazquez introduced himself as the student government association president. Mr. Velazquez indicated he looks forward to getting to know many of the staff and board of trustees and is extremely excited to represent ISU's students this year.

### **REPORT OF THE ISU FOUNDATION PRESIDENT (Mr. Carpenter)**

Mr. Carpenter was unable to attend and provided a written overview of Foundation and Alumni activities.

### **REPORT OF THE UNIVERSITY PRESIDENT (Dr. Bradley)**

President Bradley stated that it is great to have the students back on campus and hoped everyone had a wonderful summer. It was a productive time for many campus leaders as work on the new strategic plan, "There's More to Blue" continued. The plan will be announced at the President's fall address to campus on September 21 with implementation to begin immediately following.

President Bradley introduced the new executive director of strategic initiatives who will be working with him in facilitating the implementation of the new plan. Monica Love comes to ISU from Tulane University where she served as deputy chief of staff and as an associate director of athletics and the senior women's administrator for athletics. Prior to working at Tulane, she served as associate director of athletics at the U.S. Military Academy at West Point and as assistant director of athletics for compliance and enforcement at Baylor University. Monica has a bachelor's in business administration from Drake University, an MBA from Tulane and a Juris Doctorate from the University of Iowa.

President Bradley congratulated Tracy Osborne and everyone involved in the welcome week activities including the outstanding orientation leaders, and staff from residential life, information technology, student affairs, public safety, University College, and other offices throughout campus as well as the more than 700 students who volunteered to help.

Congratulations also goes to Nancy Rogers, Heather Miklozek, Jessica Starr and the entire Center for Community Engagement team for a record-breaking Donaghy Day. There were 1,936 students who participated in service projects across three different counties. President Bradley thanked the dozens of faculty and staff members who volunteered to oversee these activities.

President Bradley announced that the official enrollment numbers won't be available until the fifth day of classes. Coming off of last fall's record numbers, it appears that enrollment will be stable this year.

The President indicated the groundbreaking for the \$64 million expansion and renovation of the Health and Human Services Building, the largest state-funded construction project in ISU's history, took place earlier in the day. President Bradley thanked Sen. Luke Kenley for providing comments at the ceremony and Congressman Larry Buschon, State Senator Jon Ford, State Representatives Bob Heaton, Clyde Kersey and Alan Morrison and Mayor Duke Bennett for participating as well. He remarked that the new facility will fill a critical need for additional

classroom and laboratory space for ISU's growing health related fields. This project will also feed into the redevelopment of the Third Street/Chestnut Street corridor as the main entryway to campus.

The trustees' agenda includes a request to approve the transfer of the ICON building, located at 1 Sycamore Street, to the City of Terre Haute Redevelopment Commission for future development. Core Redevelopment is interested in converting the site into apartments which would be a great boost to the Riverscape redevelopment efforts and would save the university the significant costs of tearing the building down.

The President also mentioned that the trustees were able to tour the newly remodeled 7<sup>th</sup> floor of the Hulman Memorial Student Union. The remodeled space includes the Multi-cultural Services and Programs area and the LGBT Student Resource Center, La Casita Student Resource Center, Women's Resource Center, and International Student Resource Center. This is part of Vice President Willie Banks' efforts to expand services to students.

President Bradley called upon Vice President Banks to introduce two new staff members. Brice Yates, the new director of the African American Cultural Center, and Amanda Hobson, assistant dean of students and director of the Women's Resource Center, were introduced.

President Bradley then called upon Vice President Nancy Rogers to introduce the new executive director of Career Services, Bryan Lubic.

The president noted that the University's Sesquicentennial Celebration is continuing. A list of events was provided to the trustees.

#### **REPORT OF THE BOARD CHAIRPERSON (Mr. Campbell)**

Trustee Campbell reported that the President's Evaluation went very well. He indicated that the trustees recognize that Indiana State has had an incredible year. He noted improvements in retention and graduation rates, the renovation of Normal Hall, the kickoff of the Sesquicentennial Era, the continued upgrading of student housing, the new Health and Human Services Building expansion and renovation, and the national recognition the university continues to receive for community engagement.

He indicated that the board is incredibly proud of everything that the President has accomplished and recognizes that this work has not been done by the President alone, and required hard work on behalf of everyone.

Trustee Campbell indicated that there is more work to do. He shared the goals the board had discussed for the President for the current academic year including paying particular attention to enrollment, student success, government relations, affordability, fundraising and donor stewardship, the continued remodeling of Sycamore Towers, the Health and Human Services project and continuing to work with the partners in the City, County and Convention and Visitors Bureau to advance the Hulman Center project. He added that all of the goals and work of the trustees, administration, faculty and staff needs to be in alignment with the goals of the new "There's More to Blue" strategic plan, including aligning the promotion and tenure guidelines with the priorities in the strategic plan.

### 5b1 Series R Bond Resolution

The University is preparing for the sale of new bonds to finance the renovation/expansion of the College of Health and Human Services facility as approved by the 2015 Indiana General Assembly in the amount of \$64 million. The new bonds may also include the refunding of the outstanding Series M and Series O Bonds if sufficient debt service savings exist based on market conditions and contingent on approval of the State of Indiana. The proposed bond issue, to be designated Series R, would include the issuance of new debt and refunding all outstanding principal of Series M and Series O Bonds, maturing after October 1, 2016, that were issued June 29, 2007 and April 7, 2011, respectively. Total proceeds from the new issuance and refunding will not exceed \$98.5 million. The debt service savings benefit both the State of Indiana and Indiana State University.

The resolution, shown below, allows for authorization and approval of the sale of Indiana State University Student Fee Bonds, Series R.

**Recommendation:** Approval of the resolution shown below allowing the President of the University and/or Treasurer of the Board of Trustees to develop and submit a plan of financing, to obtain all necessary state agency approvals for the sale of Series R Bonds.

**Mr. Taylor reported that the Finance Committee recommends the approval of the item as presented. The board voted to approve the item as presented. Mr. Minas abstained in both the Finance Committee and Board Meetings.**

RESOLUTIONS OF THE BOARD OF TRUSTEES FOR THE  
INDIANA STATE UNIVERSITY BOARD OF TRUSTEES  
APPROVING AND AUTHORIZING THE SALE OF THE  
INDIANA STATE UNIVERSITY STUDENT FEE BONDS, SERIES R

WHEREAS, the Board of Trustees (the “Board”) of the Indiana State University Board of Trustees (the “University”) has full power and authority under and by virtue of the laws of the State of Indiana, including, more particularly, the provisions of Indiana Code 21-34-1 et seq., to issue bonds to finance or refinance academic and building facilities on its campus in Terre Haute, Indiana, such bonds to be secured by Student Fees; and

WHEREAS, the Board has determined that a necessity exists to consider financing (i) the advance refunding in part of the Indiana State University Student Fee Bonds, Series M, issued on June 29, 2007 in the original aggregate principal amount of \$47,730,000 (the “Series M Bonds”), comprised of all the Series M Bonds except for the Series M Bonds maturing on October 1, 2016; (ii) the current refunding in part of the Indiana State University Student Fee Bonds, Series O, issued on April 7, 2011 in the original aggregate principal amount of \$8,695,000 (the “Series O Bonds”), comprised of only those Series O Bonds maturing on October 1, 2019 through and including October 1, 2024, and on October 1, 2027; (iii) the advance refunding of an additional portion of the Series O Bonds, comprised of only those Series O Bonds maturing on October 1, 2017, October 1, 2018, October 1, 2025, October 1, 2026 and October 1, 2028 through and including October 1, 2030; and (iv) all or a portion of the costs of the acquisition, construction, expansion, renovation and equipping of certain academic and building facilities on the University’s campus in Terre Haute, Indiana, as described in Exhibit A attached hereto (the “Project”); and

WHEREAS, the University has heretofore executed and delivered to First Financial Bank, N.A. (formerly known as Terre Haute First National Bank), as trustee (the “Trustee”), a certain Trust Indenture dated as of November 1, 1985, as heretofore supplemented and amended (the “Indenture”), for the purpose of securing its Indiana State University Student Fee Bonds (hereinafter sometimes referred to as the “Bonds”), issued from time to time thereunder; and

WHEREAS, the Treasurer of the University (the “Treasurer”) has investigated, developed and evaluated a Plan of Financing (the “Plan of Financing”) for financing (i) the advance refunding in part of the Series M Bonds, (ii) the current refunding in part of the Series O Bonds, (iii) the advance refunding of an additional portion of the Series O Bonds, and (iv) all or a portion of the costs of the Project; and

WHEREAS, the Board now desires to authorize the Treasurer to effectuate such Plan of Financing for financing (i) the advance refunding in part of the Series M Bonds, (ii) the current refunding in part of the Series O Bonds, (iii) the advance refunding of an additional portion of the Series O Bonds, and (iv) all or a portion of the costs of the Project; and

WHEREAS, Article IV of the Indenture authorizes the issuance of additional series of Bonds by the University and the authentication and delivery of those additional series of Bonds by the Trustee under the conditions set forth in Article IV, which conditions have been complied with (subject to approval by the State Budget Committee and the State Budget Director of the State of Indiana) so as to authorize the issuance, authentication and delivery of an additional series of Bonds

by the Trustee under the conditions set forth in Article IV, to provide the funds required to finance (i) the advance refunding in part of the Series M Bonds, (ii) the current refunding in part of the Series O Bonds, (iii) the advance refunding of an additional portion of the Series O Bonds, and (iv) all or a portion of the costs of the Project, as well as certain related costs incidental to the financing; and

WHEREAS, the Board now desires to authorize the execution and delivery of the Indiana State University Student Fee Bonds, Series R (the "Series R Bonds"), and a Fifteenth Supplemental Indenture (the "Fifteenth Supplemental Indenture"), a Construction and Rebate Agreement (the "Rebate Agreement"), an Escrow Deposit Agreement (the "Escrow Agreement"), a Preliminary Official Statement (the "Official Statement"), a final Official Statement, a Bond Purchase Agreement (the "Bond Purchase Agreement"), a Sixth Supplement to Amended and Restated Continuing Disclosure Undertaking Agreement (the "Sixth Supplement to Undertaking Agreement"), forms of the Series R Bonds, and any further documents required to complete the execution and delivery of the Series R Bonds (subject to any approvals as may be required from the State Budget Committee and the State Budget Director of the State of Indiana); and

WHEREAS, there has now been made available to the Board a form of Fifteenth Supplemental Indenture, a form of Rebate Agreement, a form of Escrow Agreement, a form of Official Statement, a form of Bond Purchase Agreement and a form of Sixth Supplement to Undertaking Agreement in connection with the issuance of the Series R Bonds in an aggregate principal amount not to exceed \$98,500,000, plus additional amounts needed for underwriter's discount as described below and any original issue discount or bond premium, as permitted by law, capitalized interest (if any), costs of issuance, any amounts necessary to provide for any debt service reserve fund, and costs of any premiums for bond or debt service reserve fund insurance; and

WHEREAS, the Board now desires to authorize and direct the President of the University (the "President") and the Treasurer to do any and all acts and things, to seek all necessary approvals from the State Budget Committee and the State Budget Director of the State of Indiana, and to make and approve all changes in form or substance to the Fifteenth Supplemental Indenture, the Bond Purchase Agreement, the Rebate Agreement, the Escrow Agreement, the Sixth Supplement to Undertaking Agreement or the Official Statement, necessary to secure approval of the transaction contemplated herein by any rating agency, bond insurer, reserve fund surety bond provider, or the State of Indiana; and

WHEREAS, the University intends to acquire, construct, equip, renovate and/or rehabilitate the various components of the Project, and reasonably expects to reimburse certain costs of the Project with proceeds of debt to be incurred by the University; and

WHEREAS, the University expects to issue debt not exceeding \$64,000,000 in aggregate principal amount for purposes of financing, refinancing or reimbursing all or a portion of the costs of the Project, plus additional amounts needed for costs of issuance, any debt service reserve fund, costs of any premiums for bond or debt service reserve fund insurance, underwriter's discount and original issue discount/bond premium as provided by law, capitalized interest (if any), and other incidental costs as required by the issue;

NOW, THEREFORE, BE IT RESOLVED by the Board as follows:

Section 1. The Plan of Financing investigated, developed and evaluated by the Treasurer is hereby approved and the Treasurer is hereby authorized to effectuate the Plan of Financing with respect to financing (i) the advance

refunding in part of the Series M Bonds, (ii) the current refunding in part of the Series O Bonds, (iii) the advance refunding of an additional portion of the Series O Bonds, and (iv) all or a portion of the costs of the Project.

Section 2. The issuance of the Series R Bonds by the University on the terms and conditions set forth in the Fifteenth Supplemental Indenture is hereby authorized in the total principal amount not to exceed \$98,500,000, plus additional amounts needed for underwriter's discount as described below and original issue discount or bond premium, as permitted by law, capitalized interest (if any), costs of issuance, any amounts necessary to provide for any debt service reserve fund, and costs of any premiums for bond or debt service reserve fund insurance. The Series R Bonds shall be designated the "Indiana State University Board of Trustees, Indiana State University Student Fee Bonds, Series R." The true interest cost of the Series R Bonds shall not exceed 4.00%, with a maximum underwriters' discount of 1.00%, and with such serial or term maturities and redemption features as the executing officers shall approve. The final maturity of the Series R Bonds shall not extend beyond October 1, 2035. The Series R Bonds shall be sold pursuant to the Bond Purchase Agreement at negotiated sale to a managing underwriter and co-managing underwriters as selected and appointed pursuant to Section 13 below.

Section 3. The President and the Treasurer are hereby authorized and directed to do any and all acts and things, to seek all necessary approvals from the State Budget Committee and the State Budget Director of the State of Indiana, and to make and approve all changes in form or substance to the Fifteenth Supplemental Indenture, the Bond Purchase Agreement, the Rebate Agreement, the Escrow Agreement, the Sixth Supplement to Undertaking Agreement or the Official Statement necessary to secure approval of the transaction contemplated herein by any rating agency, bond insurer, reserve fund surety bond provider, or the State of Indiana.

Section 4. The Fifteenth Supplemental Indenture is hereby approved in substantially the form submitted to the Board and is made a part of this Resolution as if fully set forth herein. The Chair and the Vice Chair of the University (the "Chair" and the "Vice Chair," respectively), or either of them, are hereby authorized to execute and deliver, and the Secretary and the Assistant Secretary of the University (the "Secretary" and the "Assistant Secretary", respectively), or either of them, are hereby authorized to attest the signature of and to imprint the corporate seal of the University on the Fifteenth Supplemental Indenture in substantially the form presented to the Board, with those changes in form or substance that the President and Treasurer, and the officers executing the Fifteenth Supplemental Indenture, shall approve, such approval to be conclusively evidenced by the execution and delivery thereof.

Section 5. The Official Statement is approved in substantially the form submitted to the Board and is made a part of this Resolution as if fully set forth herein. The Treasurer is hereby authorized and directed to make those changes in form or substance as are necessary or appropriate, to authorize the distribution of the Official Statement, to deem an Official Statement to be final or nearly final for purposes of applicable Securities and Exchange Commission rules, to execute and deliver the form of any final Official Statement with those changes in form or substance that the Treasurer shall approve, and to cause printed copies of the Preliminary and final Official Statements to be provided to those prospective purchasers, investors and other persons as he may deem advisable in order to market the Series R Bonds, and any such prior actions are hereby ratified and confirmed.

Section 6. The Bond Purchase Agreement is hereby approved in substantially the form submitted to the Board and is made a part of this Resolution as if set forth fully herein. The Chair, Vice Chair and Treasurer, or any of them, are hereby authorized to execute and deliver the Bond Purchase Agreement in substantially the form submitted to the Board, with those changes in form or substance that the President and Treasurer, and the officers executing the Bond Purchase Agreement, shall approve, such approval to be conclusively evidenced by the execution and delivery thereof.

Section 7. The Rebate Agreement is hereby approved in substantially the form submitted to the Board and is made a part of this Resolution as if set forth fully herein. The Chair, Vice Chair and Treasurer, or any of them, are hereby authorized to execute and deliver, and the Secretary or Assistant Secretary, or either of them, is hereby authorized to attest the signature of and to imprint the corporate seal of the University on, the Rebate Agreement in



substantially the form submitted to the Board, with those changes in form or substance that the President and Treasurer, and the officers executing the Rebate Agreement, shall approve, such approval to be conclusively evidenced by the execution and delivery thereof.

Section 8. The Escrow Agreement is hereby approved in substantially the form submitted to the Board and is made a part of this Resolution as if set forth fully herein. The Chair, Vice Chair and Treasurer, or any of them, are hereby authorized to execute and deliver, and the Secretary or Assistant Secretary, or either of them, is hereby authorized to attest the signature of and to imprint the corporate seal of the University on, the Escrow Agreement in substantially the form submitted to the Board, with those changes in form or substance that the President and Treasurer, and the officers executing the Escrow Agreement, shall approve, such approval to be conclusively evidenced by the execution and delivery thereof.

Section 9. The Sixth Supplement to Undertaking Agreement is hereby approved in substantially the form submitted to the Board and is made a part of this Resolution as if set forth fully herein. The Chair, Vice Chair, and Treasurer, or any of them, are hereby authorized to execute and deliver the Undertaking Agreement in substantially the form submitted to the Board, with those changes in form or substance that the President and Treasurer, and the officers executing the Sixth Supplement to Undertaking Agreement, shall approve, such approval to be conclusively evidenced by the execution and delivery thereof.

Section 10. The Treasurer is hereby authorized to prepare the bond forms required for use in the issuance of the Series R Bonds, on the terms and conditions set forth in the Fifteenth Supplemental Indenture, and to cause the same to be executed manually or by facsimile by the proper officers of the University as provided in the Fifteenth Supplemental Indenture and the Indenture. Upon execution of the Series R Bonds, the Treasurer shall deliver the Series R Bonds to the Trustee for authentication, and upon their authentication, the Treasurer is authorized and directed to deliver the Series R Bonds to the purchasers thereof on payment of the purchase price, which price shall reflect the underwriter's discount permitted by this Resolution and original issue discount or bond premium, if any, as permitted by law.

Section 11. The Chair, Vice Chair, President, Treasurer, Secretary and Assistant Secretary, or any of them acting singly or jointly, are hereby authorized and directed to do any and all further acts and things necessary underlying the execution and delivery of such additional or supporting agreements, documents or certificates as may be requested or necessary in order to complete the transactions contemplated by the Bond Purchase Agreement, the Fifteenth Supplemental Indenture, the Rebate Agreement, the Escrow Agreement, the Sixth Supplement to Undertaking Agreement and the Official Statement hereby authorized.

Section 12. The Board hereby approves the Treasurer to make the necessary calculations with respect to the coverage factor of Student Fees to Maximum Annual Debt Service, after the pricing of the Series R Bonds, to be shown in the Official Statement for the Series R Bonds.

Section 13. The Board hereby ratifies the selection of, and appoints, Barclays Capital Inc. as senior managing underwriter for the Series R Bonds, and City Securities Corporation, Citigroup Global Markets Inc., Siebert Brandford Shank & Co., LLC, and Mesirov Financial, Inc., as co-managing underwriters for the Series R Bonds, and further authorizes the President and the Treasurer in their discretion to select one or more additional co-managing underwriters for the Series R Bonds (or none at all). The Board hereby ratifies the selection of, and appoints, (i) Ice Miller LLP as bond counsel and special disclosure counsel for the Series R Bonds, and (ii) Blue Rose Capital Advisors, LLC as financial advisor for the Series R Bonds.

Section 14. The use of bond insurance is hereby approved in connection with the Series R Bonds, if deemed beneficial to the University in the best judgment of the President and the Treasurer. The President and Treasurer are hereby authorized to select a bond insurer, if deemed beneficial at their discretion and using their best judgment, and

to accept any commitments and execute any agreements which may be necessary or advisable in connection with any such bond insurance for the Series R Bonds.

Section 15. The Board hereby finds that (i) the advance refunding in part of the Series M Bonds, (ii) the current refunding in part of the Series O Bonds, and (iii) the advance refunding of an additional portion of the Series O Bonds, as described herein, will benefit the University because, in each case, (x) a net savings to the University will be effected; and (y) the net present value of principal and interest payments on the corresponding Series R Bonds will be less than the net present value of the principal and interest payments on the advance refunded Series M Bonds, the current refunded Series O Bonds, and the advance refunded Series O Bonds, respectively.

Section 16. Notwithstanding anything to the contrary contained in these Resolutions, the Board hereby authorizes the President and the Treasurer to make all final decisions, at their discretion and using their best judgment, regarding whether the plan of finance for the Series R Bonds will include (i) the advance refunding in part of the Series M Bonds, (ii) the current refunding in part of the Series O Bonds, and/or (iii) the advance refunding of an additional portion of the Series O Bonds, as described herein, based on their assessment of market conditions at the time of the sale of the Series R Bonds.

Section 17. The Board hereby declares its official intent to acquire, construct, equip and/or rehabilitate the Project described in Exhibit A; to reimburse certain costs of acquiring, constructing, equipping and/or rehabilitating the Project with proceeds of debt to be incurred by the University; and to issue debt not exceeding \$64,000,000 in aggregate principal amount for purposes of financing, refinancing or reimbursing all or a portion of the costs of the Project, plus additional amounts needed for costs of issuance, any debt service reserve fund, costs of any premiums for bond or debt service reserve fund insurance, underwriter's discount and original issue discount/bond premium as provided by law, capitalized interest (if any), and other incidental costs as required by the issue.

#### EXHIBIT A

#### THE PROJECT

The Project consists of the acquisition, construction, expansion, renovation and equipping of certain academic and building facilities for the University including, in particular, the renovation of the University's facility for the College of Health and Human Services, including (i) major upgrades to building systems, (ii) reconfiguring of interior spaces to enable academic programs to function more efficiently, and (ii) the construction of an approximately 87,000 square foot addition to the facility.

The Project has a total cost of \$64,000,000. Ratio Architects, Inc. of Indianapolis, Indiana is the architect for the Project. Work on the Project began in July, 2016 and is scheduled for completion in March, 2019.

## 5b4 Transfer of Property

The Indiana State University Foundation gifted to the University real estate located at 1 Sycamore Street in December 2009 to serve as a new site for future athletic facilities. This property is west of the main campus and borders the Wabash River. The site also has a large industrial-type building originally constructed by the American Can Company in 1923 and used by various industrial successors over the years, the last being ICON, the name by which the building is known. Although the University's new track and field facility was constructed nearby, there are no current plans for University use of the ICON building.

After careful consideration of potential uses for the structure including a proposal from CORE Redevelopment, LLC., the University recommends transferring the real estate and improvements at 1 Sycamore Street to the City of Terre Haute Redevelopment Commission for future development (in accordance with I.C. 21-36-3-7). As part of the transfer, the University will retain approval rights for any design plans or future use of the property. We anticipate that the Redevelopment Commission will work with CORE Redevelopment, LLC to convert the site to commercial real estate uses. For that reason, we also recommend granting a permanent easement to CORE Redevelopment, LLC for the design, construction, maintenance, and operation of surface parking at the site. The designated parking location would be 500 North 1st Street on property conveyed by CSX to the University.

The transfer is subject to operating standards and covenants that will run with the property. Any owner of the property will be bound to observe those standards and covenants.

**Recommendation:** Authorize the Treasurer of the University to execute all documents required to transfer the real estate and improvements (i.e. building) located at 1 Sycamore Street to the City of Terre Haute Redevelopment Commission subject to operating standards and covenants and the granting of a permanent easement for surface parking at 500 North 1<sup>st</sup> Street upon property closing with CSX Real Property, Inc. Transfer of property and easement is contingent upon selected developer securing necessary financing.

## 5d Reactivated Program, Guidance and Psychological Services: Specialization Counselor Education PhD

The Department of Communication Disorders, Counseling, School, and Educational Psychology and the Bayh College of Education proposal to add a specialization of Counselor Education to the existing Ph.D. in Guidance and Psychological Services.

The following information supports the addition of the program:

- As of July 31, 2013, the Council for Accreditation of Counseling and Related Educational Programs (CACREP) requires Counseling faculty members to hold a Ph.D. in Counselor Education in order to teach in CACREP-accredited doctoral programs.
- As of January 1, 2014, all *new* Counseling faculty positions **must** be filled by an individual with a Ph.D. in Counselor Education to maintain accreditation of their Master's level programs counselor training programs.
- The National Board for Certified Counselors (NBCC) recently passed rules requiring graduation from a CACREP-accredited master's program to be allowed to sit for the National Counselor Examination (NCE). This has tremendous significance in that many states use the NCE as their state-level licensure examination. This change in Master's-level accreditation and licensing requirements further increases the need for CACREP accredited doctoral programs to meet the growing need for CACREP master's-level programs.

These changes in policy (along with others not presented here) will vastly increase the demand for Clinical Mental Health Counselors and Counselor Educators across the country. An additional factor is the expected retirement of many current counselor education faculty over the next several years. Currently, there are no Counselor Educator Ph.D. programs in Indiana.

**RECOMMENDATION:** That the **Guidance and Psychological Services: Specialization Counselor Education Ph.D.**, in the College of Education, be approved effective Fall 2017.

## 5e New Program, Middle School Science Minor

There is a critical need for science teachers in middle schools, both in Indiana and throughout the United States. This minor is designed for Elementary Education or Secondary Education majors who want to add a middle school science licensure to their initial teaching licensure. This minor will provide the community with more middle science teachers. Furthermore, students who choose to add this second licensure will benefit from having a broader range of career opportunities as well as extra content for their resume.

Elementary Education and Secondary Education majors can enroll in this program.

The proposal has been reviewed by the Science Education Advisory committee. The Science Education Advisory Committee agreed that the required courses in the Middle School Science Minor cover all IN core science standards for grades 5 -8.

This minor, in conjunction with an education major, and the appropriate state licensure tests will qualify students to teach middle school science. This minor cannot be used as an initial instructional license. Without a teaching license, this alone will not satisfy requirements for teaching science in middle schools. Students who complete the middle school science

minor in conjunction with an Elementary Education or Secondary Education major will have satisfied the Foundational Studies requirements in Laboratory Sciences.

The proposal has been approved by the Dean of the College of Arts and Sciences, Faculty Senate, and has the support of the Provost and Vice President for Academic Affairs.

**RECOMMENDATION:** That the new program, Middle School Science Minor, be approved effective Fall 2017.

## 5f Proposed Modification Program Specific Fees<sup>1</sup>

### Effective for the Fall Semester 2016

The Board has in the past approved both special fees tied to courses and fees that are program related, such as with the Doctor of Physical Therapy. The program fees were proposed and approved by the Board of Trustees as per semester fees; in the case of the DPT the approved program fee was \$1000/semester. At the time program fees were approved and implemented, we had no way in our current system to assess a program fee. We were (and still are) only able to assess special fees at the course level. Therefore, when program fees were approved, they were tied to specific courses (1 each semester) in order to charge students. The courses were included as part of the board recommendations (I.e. Program fee tied to these courses). Unfortunately, when the curriculum changes, those courses may be moved or eliminated which might result in students being assessed no program fee one semester or double or triple the program fee in another semester. We seek board approval that all initial per term program fees approved by the Board supersede the specific course numbers used to assess the program fees and allow us to make adjustments to the courses as necessary to ensure that all program fees are appropriately assessed each term.

**Recommendation:** Approval to allow all program fees to be assigned to courses as needed, effective with Fall 2016 fee assessments, to ensure that all per semester program fees are appropriately assessed.

## 5g Approval of additions to Policy 245 and Policy 246 and Approval of Policy 399

The ISU Faculty Senate has requested approval of additions to Policy 245 Faculty Constitution and Policy 246 Faculty Bylaws and approval of Policy 399 Interpretation of Faculty Handbook Policies. The proposed changes will provide clarification to faculty about the process to request interpretation of policies specifically related to faculty governance and faculty academic responsibilities. The additions of Policy 246.16 and Policy 399 were approved by the Faculty Senate in November, 2016 and the addition of Policy 245.10 was approved by the ISU faculty in January, 2016.

### Proposed Addition of 245.10

**245.10 Interpretation** All questions regarding the Constitution of the Faculty of Indiana State University shall be directed to the Faculty Senate Chairperson. The Faculty Senate Chairperson shall immediately consult the other Senate officers and

the Provost on all such questions of interpretation. Their agreed-upon interpretation shall be communicated to the person or body asking for it and shall be considered the only valid interpretation of these sections. If they fail to agree on an interpretation, they will present both the question and their respective interpretations to the University President who shall render the final interpretation. The ISU Board of Trustees retains all authority as designated by the Indiana Code and this Handbook.

#### **Proposed Addition of 246.16**

**246.16 Interpretation** All questions regarding the Bylaws to the Faculty Constitution shall be directed to the Faculty Senate Chairperson. The Faculty Senate Chairperson shall immediately consult the other Senate officers and the Provost on all such questions of interpretation. Their agreed-upon interpretation shall be communicated to the person or body asking for it and shall be considered the only valid interpretation of these sections. If they fail to agree on an interpretation, they will present both the question and their respective interpretations to the University President who shall render the final interpretation. The ISU Board of Trustees retains all authority as designated by Indiana law and the ISU Handbook.

#### **Proposed Policy 399 Interpretation of Faculty Handbook Policies.**

**399.1 Interpretation** All questions regarding material in sections 300-399 of this Handbook shall be directed to the Faculty Senate Chairperson. The Faculty Senate Chairperson shall immediately consult the other Senate officers and the Provost on all such questions of interpretation. Their agreed-upon interpretation shall be communicated to the person or body asking for it and shall be considered the only valid interpretation of these sections. If they fail to agree on an interpretation, they will present both the question and their respective interpretations to the University President who shall render the final interpretation. The ISU Board of Trustees retains all authority as designated by Indiana law and the ISU Handbook.

**Recommendation:** Approve the addition of Policy 245.10, Policy 246.16, and Policy 399.1 to the University Handbook.

## **5h Approval of the Presidential Goals for 2016-17**

1. **Enrollment:** Continue to grow enrollment with a special emphasis on increasing first-time freshmen, transfer and distance enrollments.
2. **Retention and Graduation Progress:** Continue to develop a culture of student completion across campus.
3. **State Appropriation:** Obtain an increase in our appropriation from the legislature in the upcoming budget session.
4. **Affordability:** Keep tuition and fee increases at or below inflation.
5. **Capital Appropriation:** Obtain approval of our request for fee replacement funding for capital improvement.
6. **Strategic Plan:** Kick-start the implementation of our new strategic plan "There's more to Blue" which will be launched at the President's Fall Address on September 21.

7. **Sycamore Towers remodel:** Complete the renovation of Cromwell Hall and begin work on Rhoads. Partner with Sodexo to plan the expansion and remodeling of Sycamore Dining.
8. **Health and Human Services Building addition and renovation:** Keep the project moving forward.
9. **Hulman Center remodel:** Work with the State of Indiana and our local partners (Vigo County, City of Terre Haute and the Convention and Visitors Bureau) to design, obtain financing approval and begin construction of a remodeled arena and new convention center.
10. **Philanthropy:** Increase private giving to Indiana State and improve the stewardship to donors.
